Adapting to the ever-changing work environment post-Pandemic, E Center Human Resources team has focused on impacting health and wellness.

Throughout the year, weekly motivational messages have been shared with staff. These messages are designed to focus on not only physical health, but mental wellness opportunities. The E Center is participating with Uprise Health to provide Employee Assistance for those needing a hand with the challenges of everyday life. The first 3 visits are free for the employee and do not require the employee to be signed up for health benefits.

The Human Resources Department is moving full steam ahead and is committed to the employees of E Center. We will continue to focus on compensation, retirement, selecting great candidates, and leveraging technology to take the Agency into the future.

Information Technology

The Information Technology Department at E Center is committed to safeguarding the network by implementing a robust multilayered security approach. This includes deploying antivirus software to detect and neutralize malware, utilizing a firewall to monitor and control network traffic, and providing cybersecurity training through **KnowBe4** to educate employees on best practices. Additionally, the department fosters a security-conscious culture by raising awareness of cyber threats among staff, enforcing multifactor authentication to enhance login security, and implementing role-based file system access to ensure employees only access data relevant to their duties, collectively strengthening the organization's defenses against cyber risks.



In late 2024, the E Center CalAIM Community Supports (CS) Program launched across the 8 counties, marking a significant step forward in addressing the social determinants of health for our communities. This program provides critical services such as housing support, food security, and transportation, helping individuals overcome barriers that impact their overall well-being. Building on the foundation of Community Supports, we are now in the process of implementing the E Center CalAIM Enhanced Care Management (ECM) Program, which will offer person-centered care coordination for individuals with complex health needs. By combining these 2 programs, E Center is committed to improving health outcomes and fostering a more integrated, equitable healthcare system. As we move forward, our efforts will continue to enhance access to care and strengthen the support structures that benefit our communities, ensuring a more holistic approach to health and wellness for those we serve.

Program Highlights

E Center receives federal funding from the office of Head Start to operate 4 Head Start grants including: Migrant Seasonal Head Start, Migrant Early Head Start, Head Start, and Early Head Start. Services are provided in 8 Northern California counties for children ages 0-5. Pregnant women are served in the Early Head Start program in Butte, Sutter, and Yuba Counties. Our operation season varies based on community need and funding availability. Our services are provided in center base settings and home base settings.

Throughout this report, information and data related to our services are provided and include school readiness, family engagement, children's health, mental health, and adult and child interactions. Another focus is supporting the mental health and wellness of children, school readiness activities, and working collaboratively with local school districts to support kindergarten transition activities.

E Center prides itself on its learning environments both indoors, outdoors, and on our buses. For many of our locations, we provide bus transportation to support access to services. We firmly believe that children learn best through play and through rich learning environments utilizing Frog Street Curriculum and Partners for Healthy Babies. Environments provide opportunities for engaged, fun, inquisitive learning for the children, stretching their imaginations and expanding their math, science, language skills and social and emotional growth. Staff participate in professional development opportunities enhancing their skill in the classroom. In addition, E Center welcomes student teachers looking for work experience while in pursuit of an Early Childhood Education degree.

Children are supervised at all times by qualified teaching staff throughout their time in our classrooms. If interested, request a tour of a site or classroom.









Welcome to E Center CCTR, state funded childcare

Program Highlights

E Center received funding in July 2021 from the California Department of Social Services to operate a childcare program for infants and toddlers ages 4-weeks to 3 years of age. Services are provided in Butte, Sutter, Yuba Counties. In Butte County, centers are located in Oroville and Chico. In Sutter County, we have a site located in Yuba City. In Yuba County, centers are located in Marysville and Olivehurst.

Services are provided in center base settings for working families that require care for at least 6 hours per day, and 5 days per week. Fees for services are based on family income. Family fees were waived during this reporting period.

E Center's focus is on providing high-quality care while preparing children for their educational journey through nurturing adult/child interaction and age appropriate learning environments. We firmly believe that children learn best through play with teachers that support social and emotional well-being while providing developmentally appropriate activities for child engagement.

Children are supervised at all times by qualified teaching staff throughout their time in our classrooms. If interested, request a tour of a site or classroom. We also have plenty of opportunity for community volunteer activities.


Frog Street

E Center continues to implement the Frog Street curriculum on a 0-5 continuum for our MSHS/MEHS, HS, and 0-3 child development programs. Frog Street curriculum aligns with the Head Start Early Learning Outcomes Framework, California Learning Foundations, and the Desired Results Developmental Profile. Frog Street curriculum supports child outcomes through the scope and sequence of the implementation of Conscious Discipline, the Pyramid Model, and S.T.E.A.M.

E Center continues to implement a systemic process identifying and maintaining above average school readiness results through CLASS Observations and Child Outcomes. CLASS uses a **7-point scale**, from low to high. The scores are utilized to create current and relevant professional development opportunities for staff in support of Kindergarten readiness. CLASS focuses on three key domains: **Emotional Support**, **Classroom Organization**, and **Instructional Support**.

vegetable options. During our Farmers Market we were able to complete 100% issuance of all our vouchers/ funds.




Families on Average Served Monthly

Since the first clinic opened in 1974, E Center WIC has improved the health and well-being of millions of pregnant and postpartum women, infants, children, and families, championing access to healthy food, providing nutrition education and breastfeeding support, completing health screenings, and providing referrals. Flash forward to 2024, and E Center WIC proudly supported 6.5 million women, infants, and children, including 40% of all U.S. infants.

E Center WIC is a member of both the National and California WIC Associations, and is proud to support the Lake County community, serving an average of 2,210 participants, as well as being active in the community, participating in local events and farmers markets.
